# History Council of South Australia - President's Report AGM 2014 (Susan Marsden, 29 August 2014)

I'm pleased to present this annual report to the 12<sup>th</sup> AGM of the History Council of South Australia at the end of my second year as your President. I'll keep this brief, as the AGM will be followed tonight by the Annual Lecture. The printed report will also be available on our website, by email (or on request, by post).

We persevered with our work through 2013-14, planning events and awards and undertaking advocacy. As outlined in my first *President's Newsletter* (May 2013), our work falls broadly into two parts:

1 Maintaining and consolidating current activities: promoting members and history, including media articles; arranging events; website update and email newsletter; services to members; and awards.

2 Helping develop HCSA activities: enlarge and consult with membership; speak with general committee members; extend advocacy, liaison and lobbying; meet with or write to key staff, agencies and ministers.

All of those activities have been followed up, as detailed in the President's Newsletters and in the e-news. In summary, our calendar has included two public events during May's *About Time* History month, two Annual Lectures, and a 'gala event' for invited guests when the Governor presented the HCSA's 2014 Historians' Awards. We increased communications with members and other supporters by personal contact, with weekly e-news, and on Twitter, and completed updating our website. We developed advocacy and history-promoting activities, and to truly represent a wide constituency, with the help of my husband Michael Szwarcbord, updated the membership database, compiled a long list of potential members and contacted them by post and email. This and other actions doubled membership to around 80, including 30 rural organisations and individuals.

#### **HCSA Operations**

I'm grateful to all members of the HCSA Committee for the wide range of contributions they make, and in particular thank long-term retiring members Hugh Magarey and Margaret Anderson, as well as Alexis Tindall (succeeded earlier in 2014 by Michael Mills). I am exceedingly fortunate also in enjoying a supportive and active Executive: Richard Venus, Wilfrid Prest, Greg Slattery, Annmarie Reid, Annette Mills and Sue Coppin (David Albano retired for a time due to illness). Annmarie's weekly e-news has drawn a warm response from our members – as also expressed in person at the annual lecture in Clare on 28 August. I also thank Michael Szwarcbord for his membership secretary work.

Our income derives from membership subscriptions, which have remained unchanged for several years. We gained a third grant (\$2000) from the Cultural Fund of the Copyright Agency Ltd towards the costs of mounting our Annual lecture. The Council (General Committee) met on 25 November 2013; and in 2014 on 17 March, 16 June, and 25 August.

The Executive met on 21 October 2013, and in 2014 on 2 February, 5 May, and 21 July. The 11<sup>th</sup> AGM was held on 20 September 2013 and the 12<sup>th</sup> AGM on 29 August 2014.

#### **Awards**

In Writers' Week we made two public announcements: that, for the first time an outstanding regional historian would be honoured in the HCSA's annual award ceremony; and that Walter Marsh had won the Wakefield Companion to South Australian History Undergraduate Essay Prize 2013. Four historians were honoured with the Awards at the ceremony held on 17 July at Government House. His Excellency Rear Admiral the Honourable Kevin Scarce AC CSC RANR presented the Awards to: Ms Christeen Schoepf - Emerging South Australian Historian of the Year Award; Dr Brian Dickey - South Australian Lifelong History Achievement Award; Ms June Edwards - South Australian Historian of the Year Award; and Ms Paula Bartsch - South Australian Regional History (inaugural). We congratulate them, and thank His Excellency and staff for hosting the Awards, the three judges: John Bannon, Carol Fort and Susan Marsden, nominators and nominees, who were all invited to the event. #### **Events (2014)**

21 March: Joint State Library of SA and HCSA workshop, at Port Pirie Public Library. 29 May and 31 May: SA Film Corporation's 1970s films on 'The changing role of women', co-hosted with Flinders University Library, with talks by film experts and historians, including HCSA committee member Professor Melanie Oppenheimer. Audiences of around 60 appreciated the refreshments supplied by HCSA.

17 July: Governor's presentation of HCSA 2014 Awards.

28 and 29 August: Annual History Council Lecture -, on 'Colonial South Australians, 1836—1900: who were they?' Both country lecture (at Clare Town Hall) and Adelaide lecture presented by Ron Gibbs. Co-hosted with Clare Regional History Group & Clare Library Service (28th), supported by State Library of SA (29th)

29 August: HCSA 12th AGM.

## Advocacy and consultation

Consulting with members and advocacy has involved meetings with member organisations, media interviews and letters, campaigns (including membership of History SA's campaign group for a Museum of Adelaide; and with archivists, opposing the integration of State Records with the State Library), submissions (including: review of State Records Act; review of proposal to integrate State Records and State Library; review concerning reform or abolition of government boards), and meeting with MPs. These included a meeting on 22 October 2013 with Hon Ian Hunter (Minister for Environment & Conservation) and confirmed for 2 September with Hon Geoff Brock (Minister for Regional Development), for which we consulted closely with rural members.

#### Members and other supporters

I'd like to record our gratitude to members, sponsors and other supporters. For vital financial support, thanks to our members and the Cultural Fund of the Copyright Agency Ltd. We also greatly appreciated support in kind from our sponsors Brick Kiln Wines and Scorpiiion Wines, Graphic Designer Alison Fort and Ursh Richards at onlineiq and Wakefield

Press. The publisher Wakefield Press generously provided vouchers for \$400 worth of their books, presented to the four HCSA Award recipients (that is, for an additional award). We're also grateful to host venues - for our regular meetings and events, the State Library of SA and History SA - and for other events: Dr Gillian Dooley and Flinders University Library, Government House, Clare and District Historical Society and Clare Library Service.

Last year I asked: Have we raised the profile of history in SA? Of the HCSA? Have we helped to defend the concept of history and heritage? Are members and supporters being usefully informed? The answers have been 'Yes' from members, guests and other interested people, in media interviews and published letters, and in correspondence with MPs and others. But we can always do more, and ask your advice on what that might be, and how a small, voluntary member-funded organisation can most effectively do so. I believe that our collective work is significant not only because of its contribution to the cultural life of the State, but the HCSA as a non-government organisation plays a vital role in our democracy.

This is YOUR History Council, please circulate our brochures and newsletters, encourage new membership, advise HCSA representatives about issues you want to raise, and send notice of your own history events to our co-secretary and editor, Annmarie Reid, for emails and tweeting. I look forward to engaging with a much-increased membership and speaking on your behalf as 'the voice for history in South Australia'.
